2. Commission Members:

The IGU Commission on the Dynamics of Economic Spaces (CDES) does not have a formal membership base. Our 'membership' list we use to distribute information consists of 657 active email addresses from all over the world (Figure 1). Although the commission currently



has 38 member countries, half of the members (51%) are from UK (22%), USA (16%) and Germany (13%). When we add Canada (7%), Australia (6%) and New Zealand (4%) to this rate, 68% of the member are from Anglo-American countries (except Germany). In 2022, 30 new members joined the Commission.

B. Meetings

During 2022 period, the Commission held its traditional annual mini conference on Reshaping Economic Geography in times of Risk, **Uncertainty** October 5-7, 2022 in Osnabrück, Germany. The mini conference was organized by the Institute of Geography of Osnabrück University for three 3 days. 30 delegates from 17 universities in 8 countries (such as Germany, Turkey, Sweden, Poland, South Africa, USA, Netherlands and China) were attended to the conference. 19 papers were presented at the conference. The aim of the 2022 IGU-CDES Osnabrück Conference was to generate debate on existing theories and concepts in addressing risks, uncertainties and crises that are potentially reshaping the (globalized) economy, and to stir discussion on the need to rethink or develop new concepts in Economic Geography. The conference was held under six paper sessions plus two plenary sessions on the following themes:

- Regional Resilience
- Reconfiguration of global production networks
- Risk environments
- Uncertainties and risks in innovation and digitalisation
- Sustainable Development
- Impact of Covid-19 on food and beverage industry

The conference started on the first day with the interesting presentations of two keynote speakers and the discussions that followed. In her keynote address, Claudia Simon (Lower Saxony Ministry of Economic Affairs, Labour, Transport and Digitalisation) explained strategic and situational actions made by the State Ministry of Economic Affairs in the Lower Saxony of Germany during the COVID-19 crises and the global crises and presented the concrete experiences from the field. The second keynote speaker, Robert Hassink (Kiel University) debated paradigms in economic geography in times of theoretical pluralism and economic crisis and resilience.

On the second day, 4 sessions were held and the participants presented their papers on Regional Resilience, Reconfiguration of global production networks, Risk environments and Uncertainties and risks in innovation and digitalisation, respectively. These studies, which come from the perspectives of evolutionary and institutional economic geography and Global Production Networks (GPN), provided the opportunity for highly productive and intense discussions.

On the last day, 2 sessions were held and the delegates presented their papers on Sustainable Development and Impact of Covid-19 on food and beverage industry issues in these sessions. These studies, which examine the risks and opportunities created by the green transition process and COVID-19 in the agriculture, food and retail industries, presented important findings on current problems and revealed new ideas-exchanges. As always, the conference ended with a technical field trip about risk mitigation in the logistics sector to visit an international logistics company and the new Container Terminal in the Port of Osnabrück (See Photo in Annex).





On the other hand, in 2022, the Commission participated in the IGU Centennial Congress, held in Paris, France between 18-22 July 2022, by organizing three sessions titled (1) "Real estate and space: where and how to build in a context of no net land take?", (2) "Centres, Centralité Et Fonction Marchande" and (3) "Post Covid-19 Global pandemic and new world economic order 2020". Two of them were held in English and one in French, in line with the multilingual nature of the congress. In the third session organized by Indian colleagues, a total of eight presentations were planned in two slots. The four presentations of the first slot dealt with different topics from different parts of the world (link between voting pattern and socioeconomic marginalization of some areas in Poland, renewable energy industry of Korea, changes in the Polish car market due to Covid-19 pandemic, shift in the origin of FDI from West to East in Hungary). The second part can even be called the Indian section, because all the speakers and topics were related to one of the most populous countries on Earth, India, and to the various effects of the Covid-19 epidemic (caste system, food crisis, future of Folk art, global epidemics). Two of the planned four presentations were actually delivered, which dealt with the situation of the most peripheral group of Indian society (Dalits) and the food crisis of those who migrated within India, how the epidemic affected them, and what serious consequences it had. After the presentations of the sections, a lively discussion unfolded regarding the various topics. The number of participants was especially high for the first slot, approx. 30 people.

C. Networking

The IGU CDES did not engage in any collaboration with other IGU Commissions and Task Forces as well as collaboration with other international, intergovernmental, and inter- and multi-disciplinary groups in 2022.

During 2022, the CDES had no cooperative efforts with either the International Social Science Council (ISSC) or the International Council for Science (ICSU) and International Council for Philosophy and Human Sciences (CIPSH) programs.

D. Publications

1. Regular Publications:

Since long time, CDES has a very good reputation in publishing edited book and special issues in international peer-reviewed journals. CDES conferences typically result in the publication of one edited book (sometimes two) that is published as part of Routledge's (formerly





Ashgate) *Dynamics of Economic Spaces series*. The Commission has already published more than 20 edited books in the series.

CDES has renewed its contract with Routledge in 2018 to publish Commission's series of *Dynamics of Economic Spaces*. Thus, now CDES has continued its very successful publishing relationship with Routledge Publishers. The book series is entitled The *Dynamics of Economic Space* (see https://www.routledge.com/The-Dynamics-of-Economic-Space/book-series/ASHSER1030) and the Chair of the Commission serves as the Series Editor.


